

## **HARCOURT BUTLER TECHNICAL UNIVERSITY, Kanpur**

### **Instructions for Filling up the Application Form for admission to B.Tech under Kashmiri Migrants Quota**

1. Application under Kashmiri Migrant quota can be made for admission to HBTU Kanpur as per AICTE norms.
2. Such admissions will be over and above the sanctioned intake and limited to one seat in HBTU Kanpur. For these candidates, rank in JEE Mains 2017 is not required.
3. Candidates seeking admission under this quota must have obtained a minimum of 50 % marks in qualifying subjects at 10+2 level or equivalent examination as mentioned in the Eligibility criteria of the General Guidelines available on [www.hbtu.ac.in](http://www.hbtu.ac.in).
4. Eligible candidates may submit their application on the prescribed format for admission against Kashmiri Migrant quota to the Registrar, Harcourt Butler Technical University, Kanpur-208002 along with Demand Draft of Rs 2000/= in favor of Finance Controller, Harcourt Butler Technical University, Kanpur, UP payable at Kanpur.
5. The Last Date for receipt of application form in the office of the Registrar of the University is 19<sup>th</sup> July 2017 up to 05:00 PM.
6. Applications without declaration of 10+2 result or incomplete applications in any respect will not be considered.
7. The shortlisted candidates for counseling will be displayed on the university's website <http://www.hbtu.ac.in> on 24<sup>th</sup> July 2017.
8. The date of counseling of the shortlisted candidates is 28<sup>th</sup> July 2017 in HBTU Kanpur. The exact venue will be notified separately.
9. The candidates are advised to see the notice showing candidates shortlisted for counseling on the website <http://www.hbtu.ac.in> before reaching the counseling centre on scheduled date/time for counseling. NO counseling letter will be sent to the candidates separately.
10. At the time of counseling, the candidates have to submit three passport size color photographs and their original documents along with one set of photocopies of following:
  - a. Marksheet of 10+2 or equivalent examination
  - b. High School (10th Std) Certificate
  - c. Proof of being claimed quota i.e. Kashmiri migrant
  - d. Bank draft of Rs 5000/= as part admission fee in favor of Harcourt Butler Technical University, Kanpur, UP payable at Kanpur. If a candidate is admitted to the B.Tech programme, this fee would be adjusted with the university's yearly fee, else it would be refunded.
11. The latest Government orders up to the date of counseling shall be applicable for admission under Kashmiri Migrants quota.
12. The candidates are advised to keep visiting the website <http://www.hbtu.ac.in> regularly and act accordingly. The notices placed on the website shall be treated as served to the candidates.
