## **Instructions for Admission to 1<sup>st</sup> year B. Tech. programme under Kashmiri Migrants Quota**

1. Admissions in First year B. Tech. Programme under Kashmiri Migrants quota will be over and above the sanctioned intake and will be limited to one seat in HBTU, Kanpur as per the latest AICTE instructions and orders from UP Govt.
2. The Candidates, opting for admission under this scheme, need not appear in JEE(Mains)-2018.
3. Candidates seeking admission under this quota **must have clearly passed Intermediate examination of U.P. Board or 10+2 level examination or its equivalent from any recognized Board / University without grace and with a minimum 60% marks (55% marks for SC/ST Category candidates) in aggregate in three compulsory subjects (Physics, Chemistry and Mathematics). In addition, Candidate should have studied a minimum of five subjects (including the above three and English) in his/her qualifying examination.**
4. Eligible candidates may send their applications on the prescribed format for admission against Kashmiri Migrants quota to **“The Registrar, Harcourt Butler Technical University, Kanpur-208002 (UP)”** along with a Demand Draft (Non-refundable) of Rs. 2000/- in favour of "Finance Controller, Harcourt Butler Technical University, Kanpur" payable at Kanpur.
5. The last date for receipt of application form in the office of the Registrar of the University is 18<sup>th</sup> June, 2018 at 05:00 pm.
6. Applications without declaration of the result of qualifying examination or incomplete in any respect will not be considered.
7. The short listed candidates for counseling will be displayed on the University's website <http://www.hbtu.ac.in> on 21<sup>st</sup>, June 2018.
8. The date of counseling for the shortlisted candidates is 25<sup>th</sup> June, 2018 at HBTU, Kanpur. The exact venue will be notified separately.
9. The candidates are advised to see the notice for shortlisted candidates & counseling dates on University website <http://www.hbtu.ac.in> . No counseling letter will be sent to the candidates separately.
10. At the time of counseling, the candidate has to submit three passport size colour photographs and his/her original documents along with one set of photocopies of the following:
  - (a) Marksheet of 10+2 or equivalent examination
  - (b) High School (10th Std) Certificate
  - (c) Proof of claiming quota i.e. Kashmiri Migrant
  - (d) Bank Draft of Rs. 5000/- in favour of "Finance Controller, Harcourt Butler Technical University, Kanpur" payable at Kanpur. If a candidate is admitted to the B. Tech. programme, this fee would be adjusted with the University's yearly fee, else it would be refunded.
11. The latest Government Orders up to the date of counseling shall be applicable for admission under Kashmiri Migrants Quota.
12. The candidates are advised to keep visiting the website <http://www.hbtu.ac.in> regularly and act accordingly. The notices placed on the website shall be treated as served to the candidates.
