MEMORANDUM OF UNDERSTANDING
BETWEEN
HARCOURT BUTLER TECHNICAL UNIVERSITY (HBTU) KANPUR 208002 INDIA
AND
KONKUK UNIVERSITY, SEOUL, SOUTH KOREA

Harcourt Butler Technical University, Kanpur (HBTU Kanpur), in Uttar Pradesh, India and Konkuk University (KU) in Seoul, South Korea, aiming to enhance cooperation between the two institutions and to develop academic and cultural exchange, scientific research and other activities, agree as follows:

The fields of cooperation shall include Chemistry & Organic and Nano System Engineering programs offered at either institution that is felt to be desirable and reasonable for the development of cooperation between the two institutions. However, cooperative activity in any specific program, before being initiated, shall be subject to mutual consent. Such programs may include one or more of the following:

1. Faculty members/Students exchange program & their accommodation,
2. Research facility, short training/research/internship program
3. Student/faculty will manage their own food & other expenditure like travel, pocket money etc.
4. Joint research activities, supervision and proposals for funding by external agencies
5. Other programs acceptable to both Departments of the University (Konkuk University Seoul, South Korea and HBTU Kanpur, India) such as: joint guidance (Masters and/or Doctoral thesis)
6. Coordination of and participation in conferences, seminars and academic meetings.

The terms of such mutual assistance shall be discussed and agreed upon in writing by both parties prior to initiation of any particular program or activity.

The agreement shall be effective upon approval by both institutions and shall remain in effect for three years from the later of the two dates of signature. As long as one party does not give three months notice terminating this agreement. Fresh agreement will be executed. All the disputes between the parties will be decided by court at Kanpur Nagar. Thus jurisdiction of court will lie in court of Kanpur, Uttar Pradesh (India).


