## <u>Criteria for Sanction of Assistance- Revised EWS/PSFA Fund</u> <u>Rules</u>

The eligibility criterion for applying for financial assistance to the regular, registered / enrolled students will be as follows:

- The students whose gross annual income\* from all sources of his/her family\*\*is less than Rs. 4.5 Lakh (Rs. Four Lakh fifty thousand only) per annum for the last financial year (ending on 31<sup>st</sup> March).
- 2. The student should not have any pending back paper/re-appear/supplementary exam in any of the subject. In case any student has any pending back paper/re-appear/supplementary exam in any of the subject he/she will not be eligible for financial assistance.
- 3. The student should have not been involved in any indisciplinary activity in the University, for which a certificate from CoE/ DSW office is required to be submitted along with application.
- 4. The Ph.D full time/part time registered research students in the HBTU Kanpur will not come in the purview of these rules.

\* Income covered from all sources i.e salary, agriculture, business, profession etc. Income & Asset certificate must be issued after 31<sup>st</sup> March of the respective year.

\*\* The term "family" for this purpose includes the person, who seeks benefit of this scheme, his/her parents and siblings below the age of 18 years as also his/her spouse and children below the age of 18 years
