#### **Report of the Field Visit organized by the Department of Civil Engineering**

It has been observed that the employability skills of most of today's engineering graduates are far from satisfactory because the present academic programmes do not offer adequate opportunities to get the requisite on-job training/practical/industry exposure during their graduation. This limits their technical know-how and competency to theoretical knowledge only. As a step to address this issue, the Department of Civil Engineering of this institute organized a field visit to Water Treatment plant Ganga barrage, Kanpur, Wastewater Treatment plant Jajmau, Kanpur and Wastewater Treatment plant at Bingawan on November 1 and 2, 2018. Prof. Dipteek Parmar and Prof. Sunil Kumar of Civil Engineering Department were coordinators of the programme. Around 103 participants (B.Tech 4<sup>th</sup> year, B.Tech 3<sup>rd</sup> year, M.Tech 2<sup>nd</sup> yr students) visited these sites.
