Research in Reverse Engineering & 3D Printing for Healthcare Technologies

This **Memorandum of Understanding** is intended to promote mutual research cooperation between King George's Medical University, India and Harcourt Butler Technical University Kanpur, India.

The King George's Medical University, India and Harcourt Butler Technical University Kanpur, India recognized the research benefits from the establishment of institutional links, hereby agree to enter into this agreement for the following purpose.

1. PURPOSE OF AGREEMENT

The purpose of this agreement is to develop academic and educational cooperation, establish a collaborative program in research in healthcare technologies using reverse engineering & 3D printing between the two Universities and to cooperate in their mutual interest for a range of higher educational research activities.

2. AREAS OF COOPERATION

Subject to the availability of funds, resources and approval of the authorized representatives of King George's Medical University, India and Harcourt Butler Technical University Kanpur, India, both Universities agree to develop the following collaborative activities:

- (a) Conducting joint research and development project,
- (b) Cooperation in individual projects,
- (c) Organization of lectures, symposia, international meetings, conferences, and workshops,

- (d) Exchange of researchers and students,
- (e) Exchange of information, teaching materials, technological and scientific publications,
- (f) Providing opportunities for professors and researchers to give lectures,
- (g) Search for opportunities to collaborate in the future,
- (h) To share Laboratory facilities.

3. IMPLEMENTATION

- 3.1. All programs or activities implemented under the terms of this Memorandum of Understanding shall be mutually agreed upon in writing, including the necessary budget for the program of activity as the need may arise.
- 3.2. Each of the participating Universities shall be fully responsible financially for the activities carried out under its direction or by its staff, except as otherwise agreed by the parties.
- 3.3. The parties will designate one officer each who will develop and coordinate specific programs or activities between them.

4. INTELLECTUAL PROPERTY

Both partner institutions will ensure that any results and publications originating from this collaboration will be available in both India and (partner institution). Further both partner institutions will ensure that all results are discussed with each other and due credit is given while filing patent application or publishing articles.

5. DURATION AND RENEWAL OF AGREEMENT

This Memorandum of Understanding will become effective immediately after signature by the representatives of both King George's Medical University and Harcourt Butler Technical University Kanpur, India representatives for a period of Five years and is subject to revision or modification by mutual agreement.

6. AMENDMENTS

- 6.1. This Memorandum of Understanding may be amended by a written agreement signed by the representatives of both Universities.
- 6.2. In the event of any unforeseen incident during collaborative activities in either country both universities agree to negotiate a mutually acceptable solution.
- 6.3. In the event of any disagreement arise out of the application, interpretation or implementation of this Agreement, the universities shall endeavor to exercise best efforts to negotiate their differences.

7. TERMINATION OF AGREEMENT

This agreement may, at any time during its period of validity, be terminated by either party upon prior notice to the other in writing not later than Three months before termination date, provided that such termination shall not affect the completion of any program or activity underway at the time the notice of termination is given.


