## MEMORANDUM OF UNDERSTANDING

BETWEEN

Kangra, State-Himachal Pradesh**, the First Party represented herein by Prof. Dinesh PratapTiwari, Director-cum-Principal, the Competent Authority of institute (hereinafter referred as 'First Party', the institution which expression, unless excluded by or repugnant to the subject or context shall include its successors – in-office, administrators and assigns).

AND

**Harcourt Butler Technical University, Kanpur Uttar Pradesh** the Second Party, and represented herein by its Registrar, Prof. Manoj Kumar Shukla, (hereinafter referred to as "Second Party", company which expression, unless excluded by or repugnant to the subject or context shall include its successors – in-office, administrators and assigns).

(First Party and Second Party are hereinafter jointly referred to as 'Parties' and individually as 'Party')

WHEREAS:

- A) First Party is a Higher Technical Educational Institution named **Rajiv Gandhi Government Engineering College Kangra at Nagrota Bagwan, Distt. Kangra, (H.P.)**
- B) First Party & Second Party believe that collaboration and co-operation between themselves will promote more effective use of each of their resources, and provide each of them with enhanced opportunities.
- C) The Parties intent to cooperate and focus their efforts on cooperation within area of Skill Based Training, Technical Education and Research.

- D) Both Parties, being legal entities in themselves desire to sign this MOU for advancing their mutual interest.
- E) **Harcourt Butler Technical University, Kanpur Uttar Pradesh**, the Second Party is engaged in Technical Education and R&D Services in the fields of *Science, Engineering, Technology* and related fields.
- F) **Harcourt Butler Technical University, Kanpur Uttar Pradesh**, the Second Party is government funded University situated at Kanpur.
- G) **Harcourt Butler Technical University, Kanpur Uttar Pradesh** is engaged in technical education and research from last 98 years. **Harcourt Butler Technical University, Kanpur Uttar Pradesh** have fourteen degree giving & three Basic Sciences & one Humanities departments engaged in imparting training and education to students as per demand of industries and customers.

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERETO AGREE AS FOLLOWS:

CLAUSE 1: CO-OPERATION

- 1.1 Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the **Rajiv Gandhi Government Engineering College Kangra at Nagrota Bagwan (Himachal Pradesh)** and its related wings. The Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional academic opportunities for one another.
- 1.2 First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities of the faculty of each institution by providing significant inputs to each other in developing suitable teaching / training systems, keeping in mind the needs of the industry.
- 1.3 The general terms of co-operation shall be governed by this MOU. The Parties

shall cooperate with each other and shall, as promptly as is reasonably practical, enter into all relevant further agreements, deeds and documents (the 'Definitive Documents') as may be required to give effect to the actions contemplated in terms of this MOU. The term of Definitive Documents shall be mutually decided between the Parties. Along with the Definitive Documents, this MOU shall represent the future final understanding (final MoU) as to the subject matter hereof and shall supersede any prior understanding between the Parties on the subject matter hereof.

CLAUSE 2: SCOPE OF THE MoU

- 2.1 The budding graduates from the institutions could play a key role in technological up-gradation, innovation and competitiveness of an industry. Both parties believe that close co-operation between the two would be of major benefit to the student community to enhance their skills and knowledge.
- 2.2 Curriculum Design: Both the parties may take/give the inputs from each other in teaching / training methodology and suitably give suggestions to customize the curriculum so that the students fit into the industrial scenario meaningfully.
- 2.3 Industrial Training & Visits: Industry and Institution interaction will give an insight into the latest developments / requirements of the industries; both the parties shall permit the Faculty and Students to visit its premises and also involve in Training Programs of each other. The industrial training and exposure provided to students and faculty through this association will build confidence and prepare the students to have a smooth transition from academic to working career. Both the parties will provide its Labs / Workshops (as may be decided by mutual discussion at particular point of time) for the hands-on training of the learners enrolled.
- 2.4 Internships and Placement of Students: to the extent possible, both the parties will actively engage to help the delivery of the Internship and placement of students of each other into internships/jobs at their organization or other

industries located nearby or companies visiting their campus, as per AICTE internship Policy. Both the parties will register itself on AICTE Internship Policy Portal for disseminating the Internship opportunities available with them.


- 2.5 **Research and Development:** Both Parties have agreed to carry out the joint research activities in the fields of – joint academic modules, education, faculty development programmes and related research and development works leading to possibilities of collaborative research proposals, activities and services.
- 2.6 **Skill Development Programs:** Both the parties to help in training the students of each other on the emerging technologies in order to bridge the skill gap and make them industry ready.
- 2.7 **Guest Lectures:** Both the parties to extend the necessary support to deliver guest lectures to the students of the other Party on the technology trends and in house requirements, as and when requested by other Party, and as per mutual administrative convenience between two parties.
- 2.8 **Faculty Development Programs:** Both the parties to help or facilitate in training the Faculties of other Party for imparting industrial exposure/ training as per the industrial requirement considering the National Occupational Standards in concerned sector, if available.
- 2.9 Both Parties to obtain all internal approvals, consents, permissions, and licenses of whatsoever nature as may be required for offering the mutually agreed services, or Programs on the terms specified herein.
- 2.10 There is no financial commitment on the part of the **Rajiv Gandhi Government Engineering College Kangra at Nagrota Bagwan (the First Party) and Harcourt Butler Technical University, Kanpur Uttar Pradesh (the Second Party)** to take up any program mentioned in this MoU or even in final MoU. If there is any financial consideration for the activities, it will be dealt separately as per norms of both the organizations in mutual respect and consideration and as per available budget and provisions available at disposal of both the parties. The respective institutions shall bear the cost for the people of respective institutions until and unless it is specifically informed through a separate letter.


