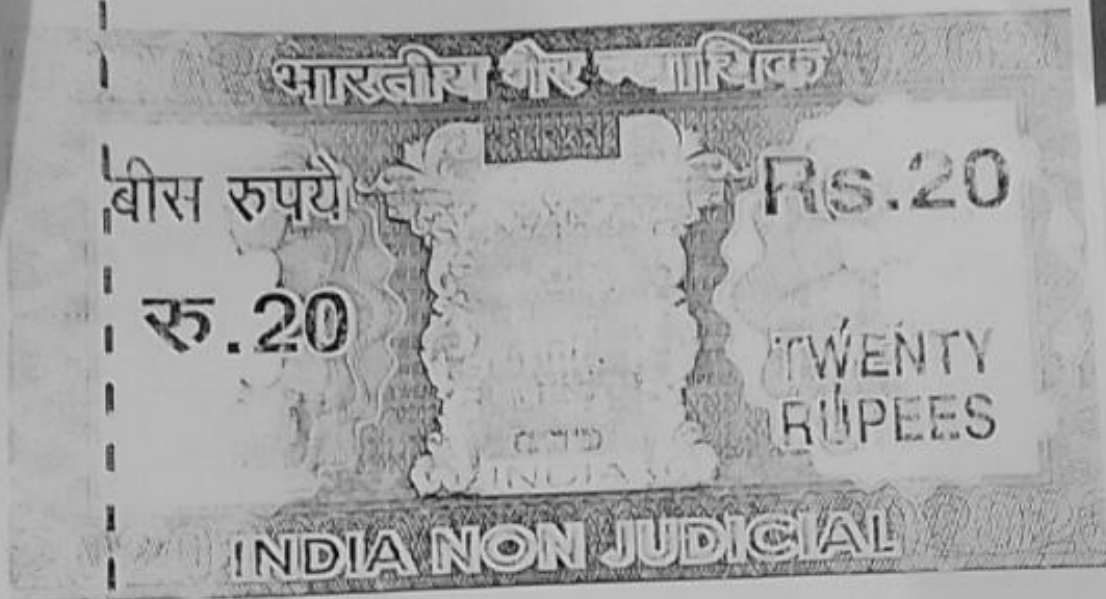
MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (MOU) is made on this \_\_\_ day of \_\_\_\_\_, 2011 by & between Harcourt Butler Technological Institute, having its postal address at Nawabganj, Kanpur - 208 002 (Uttar Pradesh) (hereinafter referred to as the "HBTI")

AND

M/s. Ruchi Soya Industries Limited Limited having its registered office at 614, Tulsiani Chambers, Nariman Point, Mumbai (hereinafter referred to as "RSIL") as under:-

WHEREAS HBTI is an institution of international repute, engaged in the field of Science and Technology. The said institution is also engaged in imparting education for the degree of B. Tech. (Oil technology).



WHEREAS RSIL is an Indian multinational Company, engaged in the manufacture of edible oil and fats having Pan India presence in said field with over 16,000 crore turn over in FY 2010-11.

WHEREAS RSIL is interested in

1. To institutionalize Dinesh Shahra Merit Award Scheme for the Oil Technologists' to promote meritocracy in the field of Oils & Fats.
2. To sponsor Dinesh Shahra Annual Lecture Day on 22<sup>nd</sup> February of every year to solemnize with his birth anniversary.
3. To drive the campus recruitment for oil technologist and other discipline.

In order to fulfill the above objective it has amicably been agreed by and between both the parties as under:

- A. That RSIL shall grant the following merit awards and financial help to the students undergoing B.Tech. (Oil Technology) in the said institution (HBTI).

1. Dinesh Shahra Merit Award Scheme for the Oil Technologists to recognize & promote meritocracy.

- a) It is decided that the Tuition fee and examination fee of students who are studying in 2<sup>nd</sup> year, 3<sup>rd</sup> year and final year B.Tech. (Oil Technology) and are topper of 1<sup>st</sup> year, 2<sup>nd</sup> year and 3<sup>rd</sup> year examinations, respectively will be sponsored by RSIL along with an appreciation letter by Mr. Dinesh Shahra, Managing Director of RSIL.
- b) The present fee of B.Tech (Oil Technology) is Rs.43000/- which includes tuition fee and examination fee. Thus total fee  $\text{Rs. } 43000 \times 3 = \text{Rs. } 129000/-$  will be transferred to the HBTI, Kanpur by 30<sup>th</sup> of June every year for the respective topper (a) above. The amount to be transferred will change as and when there will be change in the above fee structure and confirmed by the Institute.

- c) It is further decided that if the toppers of the class are the recipient of any other scholarship/financial help then the next student in the merit will be sponsored as mentioned above.
- d) The topper of the final year of B.Tech (Oil Technology) will have preferential guaranteed employment in RSIL.
2. To Sponsor annual Management lecture/Talk by distinguished speakers of the Country on 22<sup>nd</sup> February (Birth Day of Mr. Dinesh Shahra). It is decided that a lecture from one of the top Techno-Management personnel, decided mutually by the HBTI and RSIL will be organized on 22<sup>nd</sup> February every year and all the expenses related to travel & honorarium of the Key speaker as well as the tea & snacks etc. in organizing the lecture will be borne by RSIL with a maximum cap of Rs. 200000/-.
3. To drive the campus recruitment at HBTI premises for Oil Technologists and other disciplines. It is decided that RSIL will be visiting the HBTI in the month of January every year for holding
