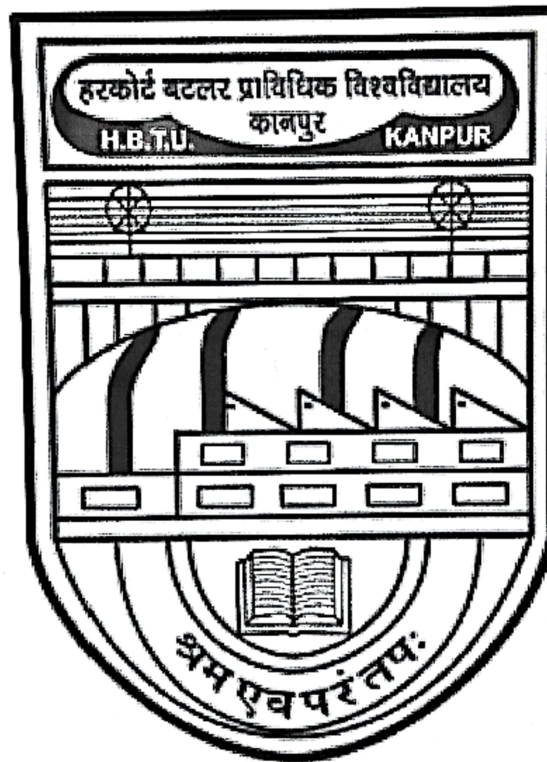

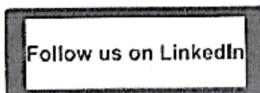

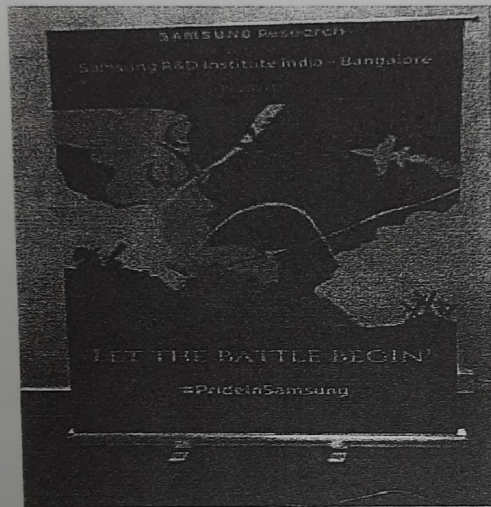

The **Training and Placement Cell** of the university organised an industry interaction programme for B.Tech CSE/IT students to make them competition ready while delving into the corporate world.



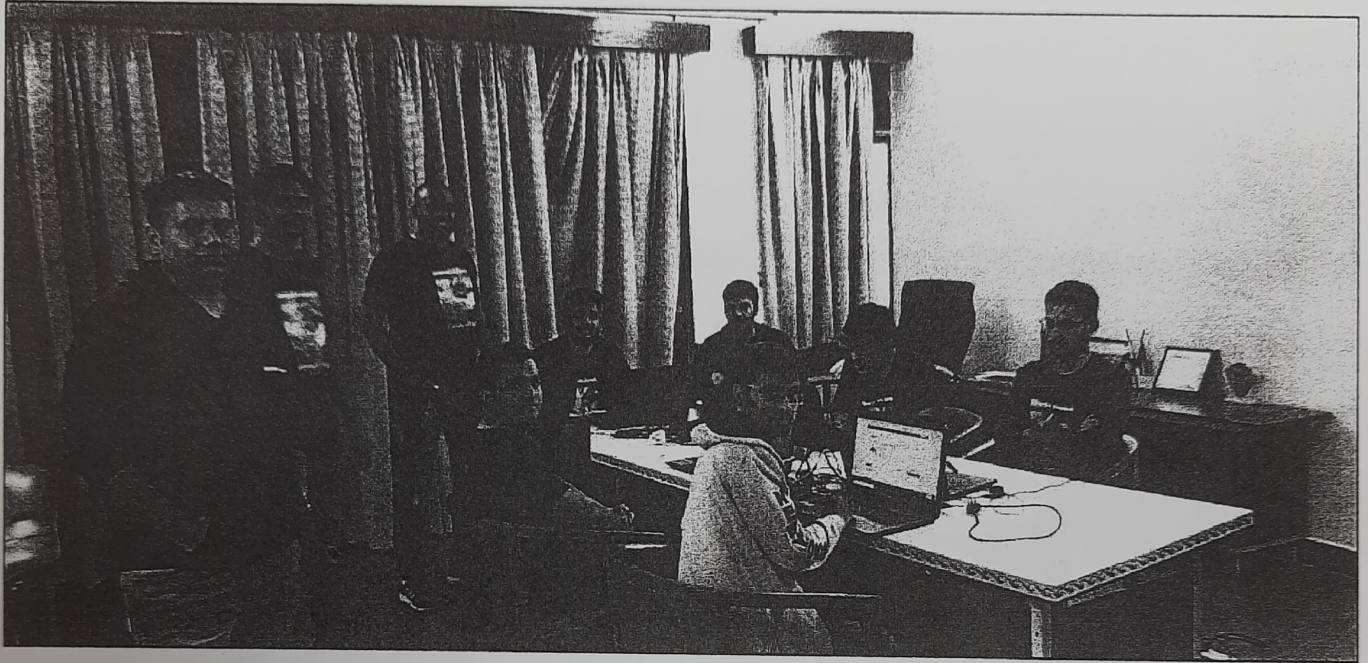
For this purpose Samsung R&D Bangalore organised Hackathon of 08 hours involving 04 coding questions to be solved by selected students in a team of two.

The team of Samsung R&D Bangalore, visiting the campus was comprised of:-

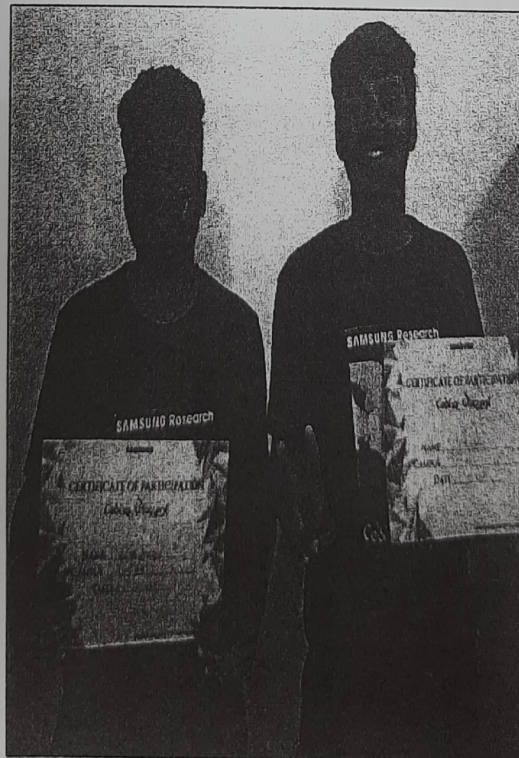
- Mr. Sudhir Kumar, Technical Head
