Activities undertaken by Association were discussed and General Body expressed satisfaction over the activities of the association in the last 10 months of FY 2018 – 2019.

AGM AGENDA NO 12.06

Discussion for strengthening the Alumni Associaion, HBTI, Kanpur

The General Body deliberated on different issues related to the strengthening of Alumni Association HBTI Kanpur.

a) Sh. K. M. Agarwal, Immediate Past President, Alumni Association HBTI Kanpur proposed for requesting HBTU Kanpur to include the President, Alumni Association HBTI Kanpur as Ex-Officio member in the Executive Council of the HBTU Kanpur.

General body approved the proposal and requested the Executive Committee to request HBTU administration for including the President, Alumni Association HBTI Kanpur as Ex- Officio member in the Executive Council of HBTU Kanpur

b) Sh. K. M. Agarwal, Immediate Past President, Alumni Association HBTI Kanpur proposed for taking necessary action long pending transfer of Alumni Fee charged by HBTI/HBTU from its students to the Alumni Association HBTI Kanpur. Dr. R. P. Singh proposed for no enhancement in the Alumni Fee being charged by the HBTU from its students. Sh. K. M. Agarwal (1977 Chemical) & Sh. Yogesh Goel (1975 Plastics) donated two window air conditioners for being installed in Alumni Lounge in Alumni Association Office, HBTU Kanpur.

General body approved the proposal and requested Executive Committee for necessary action on pending transfer of Alumni Fee charged by HBTI/HBTU from its students to the Alumni Association HBTI Kanpur. General Body thanked Sh. K. M. Agarwal & Sh. Yogesh Goel for his gesture of donating two window air conditioners to the Alumni Association.

c) Sh. Anupam Deva proposed for keeping the Life Membership fees for creation of Corpus Fund of the Alumni Association

General body approved the proposal for keeping Life Membership fees as Corpus Fund of the Alumni Association and advised Executive Committee to look into it.

d) Sh. Ravindra Murthy (1976 ME) proposed for time-bound working by the Association for seeking 12 A and 80 G Income tax approvals. Sh. Neeraj Garg (1994 MCA) requested for timelines in respect to all initiatives of Alumni Association so that deliverables are useful for the community. Sh. Ashwani Verma (1994 MCA) from North America informed difficulties faced by the alumni residing abroad in transferring life membership/registration fees / contributions for some specific cause and requested for devising mechanism for fund transfer from abroad. Sh. Verma informed that upon the martyrdom of Sh. Rajnish Yadav the USA based alumni contributed the sum of US \$ 7000 to the family of diseased. Sh. Ashish Kumar Saxena informed about the provisions for seeking one time clearance from Govt. of India for getting funds from outside India.

General body noted the observations and requested the Executive Committee for taking time-bound action.

e) Dr. R. K. Trivedi (1979 Oil) proposed for GST registration of the Alumni Association HBTI Kanpur

General body authorized Treasurer to consult the Chartered Accountant on the proposal for GST registration of Alumni Association HBTI Kanpur as per the prevailing provisions.

f) Sh. Yogesh Kumar Gupta (1976 ME) shared feedback collected from the current students and expressed concern upon poor employability of the students. Sh. Ravindra Murthy also stated the need for updating of the curriculum as per the latest need of the industry and requested alumni to extend internships to the students of the HBTU. Sh. Murthy proposed for the inclusion of alumni member in the Board of Studies of the University for updation of the syllabus and the name of relevant alumni be proposed by Alumni Association to the University.

General body took note of the observations of the members and authorized Executive Committee to do the needful.

- g) On the appeal of President, following members consented for extending mentorship support to the students and delivering expert talks. Sh. Yogesh Kumar Gupta (Mechanical), Sh. Ravindra Murthy (Mechanical), Sh. Ashwani Verma (MCA), Sh. Neeraj Garg (MCA), Sh. Sushil Garg (Chemical Engg.), Sh. Tejvir Singh Solanki (Food Technology), Sh. Ravi Vaidya (Paints Technology), Dr. Neeta Awasthi (Electronics Engg.). Regarding the syllabus, representation of alumni in syllabus preparation and forwarding the names of relevant alumni to University, the Executive Committee was requested to take necessary action in consultation with HBTU as per their requirement.
- h) General body also deliberated upon the mechanism for increasing the enrolment of Life Members of the Association and authorized Executive Committee for taking all necessary measures to increase the membership and participation of alumni in all activities of Alumni Association. General body authorised Executive Committee for

granting approvals to the chapters of Alumni Association HBTI Kanpur being set up outside India and also decide the fees for alumni residing outside India.
