Minutes of the meeting are as follows:-

Item No. 1 - Confirmation of the minutes of the 10th Annual General Body Meeting held on the 27th November, 2016 at H.B.T.I., Kanpur.

The minutes of the 10<sup>th</sup> Annual General Body Meeting held on the 27<sup>th</sup> Nov 2016 at 10.00 A.M. at the H.B.T.I. Auditorium were read. Shri Ravi Murthy, Class of 1976 (Mech. Engg.) proposed confirmation of the minutes and the proposal was seconded by Er. Sarvesh Kumar Awasthi, Class of 1976 (Mech. Engg.). The minutes were unanimously confirmed by the General Body.

### Item No. 2 - Action taken on the decisions taken in the 10th Annual General Body Meeting.

The committee expressed satisfaction over the actions taken in light of decisions taken in the 10<sup>th</sup> Annual General Body Meeting held on the 27<sup>th</sup> Nov 2016 at H.B.T.L., Kanpur. During discussions it was pointed out that though the chapter wise' branch wise, year (batch) wise and city wise data base of alumni members is available, a lot needs to be done on this account. Therefore it was unanimously accepted that a lot more effort be

put in to collect data. Several members volunteered to co-operate in the data collection process and it was decided that a strong team dedicated to this activity shall be put in perspective by the new executive committee.

The members expressed the need of stronger networking among the alumn's spread across the globe and to integrate them for mutual benefit with wider fratemity of histocortains including the faculty members, supporting staff, staff, students at H.B.T.U.. To utilize the a part of their time, treasure and talent for the benefit of current set of students and for up grading infrastructure at our alma mater. Concensus also opined that there is need for us to make deep inroads in the world of social media and other strong virtual platforms for collecting the co-ordinates of our alumnia' alumna.

The members expressed satisfaction over the society outreach work having been taken up by the alumni association for improvement in the aesthetics at our alma mater. The efforts put in by the committee for renovation of cafeteria building and the lawns surrounding the building were appreciated. The landscape and arboriculture work taken up by the alumni association inside the departments of CSE and Electrical Engg/ Civil Engg. was also appreciated.

## Item No. 3 - Ratification of the Minutes of Executive Committee Meeting(s) held between the 10th Annual General Body Meeting and the 11th Annual General Body Meeting & actions taken during this period.

The Minutes of all executive committee meetings held during the period as also the Audited Statements of Income and Expenditure with all Annexure of Accounts (As per statutory requirement) were presented in the General Body meeting by Secretary, Sh. Vivek Mishra.

Shri Arvind Kumar Garg, Class of 1987 (Civil Engg.) proposed confirmation of Minutes and statements of account for the period from 01st Apr 2015 to 31st March 2016 as also the period from 01st Apr 2016 to 31st March 2017 which was seconded by Prof. Onkar Singh, Class of 1989 (Mech. Engg.). The Resolutions of the Executive and Financial Statements were unanimously accepted. The General Body confirmed uploading of Financials on the official website for the convenience of all members of the Association.

### Item No. 4- Confirmation of the Income and Expenditure Account for the period from 01° April to 25th November 2017.

The Income and Expenditure Account for the period from 01st Apr 2017 to 25th Nov 2017 was presented by Secretary, Sh. Vivek Mishra. Shri Sanjeev Barsal, Class of 1989 (Mech. Engg.) proposed confirmation of the accounts which was seconded by Shri Pankaj Srivastava, Class of 1987 (Leather Technology). The statements were accepted by the general body. Since the elections were held and the new executive committee is now in place, the general body expressed the need for provisional audit to be completed for the period up to and including 31st December 2017 or till the date the charge is formally handed over to the new office bearers. The responsibility was assigned to the Secretary, Shri Vivek Mishra.

#### Item No. 5 - Presentation of Secretary's Report by the Secretary.

The Secretary's report was presented by the Hon. Secretary, Mr Vivek Mishra (Report enclosed at Annexure II). The General Body expressed satisfaction over the activities of the association over the past one year.

#### Item No. 6 - Discussions on the Centenary Celebrations of H.B.T.J., Kanpur.

The General Body discussed in detail the modalities for organizing the Centenary celebrations in the year 2021 when H.B.T.I. would turn Hundred. Several ideas were discussed and the consensus opinion evolved round the following points:

- To have a distinct proposal for creating an Infrastructural Asset for the Institute. Several ideas were
  discussed including construction of an Auditorium or Knowledge Centre. It was finally decided that a
  lot more discussion and brain storming would be required to conclude and converge on the job to be
  taken up. Consensus evolved on the fact that the issue be discussed in the next meeting of the
  Executive Committee.
- To divide the programs being organized in the centenary year as small celebrations to be phased out
  over the entire year.

- To prepare a Calendar for centenary celebrations and we must obtain proposals from each Department to chalk out their individual strategy to make the event a grand success. The Faculty members, Alumni, to chalk out their individual strategy to make the event a grand success. The Faculty members, Alumni, Students and Staff at the Department to work as a motivated team of individuals working for predetermined objectives. Showcasing the achievements of each of the Departments, Road shows, seminars, conferences, journals, publications etc.
- It was further opined by the members that since it would be the centenary of the University, the
  calendar of events has to come from the university administration. Further brainstorming and several
  rounds of discussions would be required to arrive at the day to day event calendar.

### Item No. 7 - Discussion for strengthening the Alumni Association, H.B.T.I., Kanpur.

The issue of resurrection/revamping of various chapters was taken up in details. Chapters which had been very active in the past but the activity has ceased during the recent past shall be revamped. Plan was chalked out to explore the alumni spread across the world. The general body unanimously opined the need to increase the number of members by efficient and effective deployment of technology and presence on the social media platforms. Mr Ravi Murthy, Class of 1976 (Mech. Engg.) took up the responsibility of effective use of facebook and linkedin. Mr Pravin Gupta, Class of 1993 (Electrical Engg.) also volunteered to help Mr Ravi Murthy on this accord. The executive committee is thankful to them.

To strengthen the data base of our Alumni/ Alumnus, it was decided that the placement cell, H.B.T.U. Kampur and the Alumni Association, H.B.T.I., Kampur may co-ordinate with various public sector undertakings for collection of data pertaining to our members working with them. This shall also go a long way in widening the scope of our association with them.

## Item No. 7 – Any other matter with the permission of Chair- Several issues were discussed at length during deliberations in the Annual General Body meeting. Details are as follows:

Since the new executive committee has been elected, the projects which have been taken up were also discussed in the general body meeting. The Hon. Secretary, Mr Vivek Mishra, informed that following projects of cooperation have been taken up with the university which are in different stages of implementation/ execution:

- (1) Memorandum of understanding has been signed with H.B.T.U. for installation of R.O. Water Plants in the East and West Campus. Mr Sunil Agarwal, Whole Time Director, KAMDHENU LIMITED, GURUGRAM, HARYANA, one of the distinguished alumni of H.B.T.U. has volunteered to get this work completed.
- (2) Development of Garden/ Landscape in the west campus of the university (In a specified area) for improvement in the aesthetics of the outfit right at the entrance to the faculty residences.
- (3) Development of Herbal Garden surrounding the gymnasium building and basketball court. This could be done on a PPP mode where development may be completed by an external agency at their own cost in exchange of the herbs produced by them.
- (4) Development of cricket turf wickets at the west campus grounds including a submersible pump for round the clock water supply (subject to the availability of resources received on this account).

The outgoing Hon. Secretary, Mr Vivek Mishra, further confirmed that Kanpur Chapter had been and is still willing to get the job completed by due diligence with Kamdhenu Limited, Gurugram on Item No. (1) and take up the job further on Item Nos (2), (3) and (4), hereinabove. The members expressed their whole hearted support to the cause and requested the new executive committee to take up the job further.




