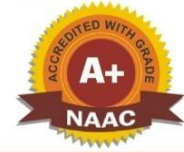

**3.3 Number of Sanctioned Posts during the year (2022-2023)**

The sanctioned posts by the Government in the University are 131. Apart from this 06 posts for Information Technology programme were approved in the year 2001 and 09 posts for MBA programme was approved in the year 2021-2022. Both the programmes are running in the self-financing mode. Therefore, in the year 2021-2022 total number of sanctioned posts in the university were  $131+06+09 = 146$ .

However, due to increased number of students and newly introduced programmes in the session, 2022-2023, additional 21 faculty members (Assistant Professor - Contractual) were recruited. Therefore, the total number of faculty members in session, 2022-2023 were **167**.
