DECLARATION

- In accordance to the provisions of Harcourt Butler Technical University Act, 2016 (Uttar Pradesh Act No 11 of 2016) as passed by the Uttar Pradesh Legislature and assented to by the Governor on April 6, 2016, Harcourt Butler Technological Institute, Kanpur is reconstituted as Harcourt Butler Technical University, Kanpur. (<http://hbtu.ac.in/wp-content/themes/hbtu/pdf/hbtu-act-2016.pdf>) (Annex 1)
- After upgradation to Harcourt Butler Technical University, Kanpur, the University submitted proposal for grant of 12 B to UGC. The UGC Expert committee visited the University on 25th and 26th April 2022 (Annex 2) and the committee in its report recommended for the grant of 12 B to the University subject to compliance to the suggestions given by the committee. Subsequently, the compliance was sent by the University. However, as per the recent letter dated 06/08/2022, it is mentioned therein that NAAC accreditation shall be mandatory for Higher Educational Institutions to become eligible for recognition under 12 B of UGC Act 1956. The University is in process to get NAAC Accreditation following which University will submit compliance alongwith documentary evidence which may be placed before the UGC Standing Committee for granting of 12 B status as the UGC Expert Committee has already visited the University (Annex 3)

THE UTTAR PRADESH HARCOURT BUTLER TECHNICAL UNIVERSITY ACT, 2016

(U.P. Act no. 11 of 2016)

[As passed by the Uttar Pradesh Legislature]

AN

ACT

to provide for reconstitution of the Harcourt Butler Technological Institute, Kanpur as the Harcourt Butler Technical University, Kanpur with a view for making it a leading Residential University to become a Centre of Excellence with focus on Research & Development and Incubation in the fields of engineering, technology, basic & applied sciences, humanities, social science & management, architecture and other professional courses, to promote studies, research and innovation in emerging areas of higher education, to further skill development through continuing education programme and knowledge incubation, also to achieve excellence in higher technical education and other matters connected therewith or incidental thereto.

WHEREAS the Harcourt Butler Technological Institute run under Harcourt Butler Technological Institute (Kanpur) Society, is an institution of Government of Uttar Pradesh affiliated to Dr. A.P.J. Abdul Kalam Technical University, Uttar Pradesh, Lucknow;

AND, WHEREAS, it is expedient to confer on the said institution, the status of a University to enable it to function more efficiently as the teaching and research center to meet the requirement of higher education and research in the field of engineering and technology, applied sciences & management sciences, foster industry relevant research & innovation and to avail better scopes and opportunities to serve the society and the nation.

IT IS HEREBY enacted in the Sixty-seventh Year of the Republic of India as follows:-

CHAPTER –I

PRELIMINARY

Short title and commencement

1. (1) This Act shall be called the Uttar Pradesh Harcourt Butler Technical University Act, 2016.

(2) It shall come into force on such date as the State Government may, by notification, appoint.

Definitions

2. In this Act, unless the context otherwise requires,—

(1) "Academic Council" and "Executive Council" means respectively the Academic Council and the Executive Council of the University;

(2) "Adjunct Professor", "Adjunct Associate Professor" or "Adjunct Assistant Professor" mean a person from academia, industry, trade, agriculture, commerce or any other allied field who is so designated during the period of collaboration or association with the University;

(3) "Authority" means an authority of the University;

(4) "Council" means the All India Council for Technical Education, established under the All India Council for Technical Education Act, 1987 (Act no. 52 of 1987);

Sir,

This has reference to the proposal submitted by the University for 12-B status and subsequent visit of the UGC Expert Committee on **25-26th April, 2022** to consider the proposal. The Report of the Expert Committee alongwith the compliance submitted by the University was placed before the Standing Committee of UGC members for consideration. The Committee recommended as under:-

"The Committee considered the report of the UGC's Expert Committee along with the compliance submitted by the University.

The Commission in 559th meeting held on 13th June, 2022 resolved that NAAC accreditation shall be mandatory for Higher Educational Institutions to become eligible for recognition under 12 B of UGC Act 1956. Further, the UGC (Mandatory Assessment and Accreditation of Higher Education Institutions) Regulations, 2012 under clause 4.1 provides that, it shall be mandatory for each Higher Educational Institutions to get accreditation by the Accreditation Agency.

The Committee has observed that university is not yet accredited by the NAAC.

In view of above, the university is required to get NAAC accreditation and submit compliance along with documentary evidence which may be placed before the Committee."

The above recommendations of the Committee along with the Report of the UGC Expert Committee were placed before the Commission in its 560th meeting {item No.1.02(a)} held on 18th August, 2022. The Commission has ratified the recommendations of the Committee.
