The university vide its Advertisement No. HBTU/Estt/02/2024 dated 07.12.2024 had invited online Applications in prescribed format for the post of “**Medical Officer**” in the university. The applications received for the post of Medical Officer were scrutinized by a duly constituted screening/scrutiny committee and scores awarded as per the “Assessment Methodology for calculation of API/Research Score for the post of Medical Officer” presented in Table B of the “Screening and Selection Criteria” uploaded on the website along with the Advertisement. Based on the recommendations of the Screening/scrutiny committee, the “**lists of candidates found eligible/provisionally eligible/not eligible along with their API score**” were displayed on this university website [www.hbtu.ac.in](http://www.hbtu.ac.in) (under the recruitment link) on 03/03/2025.

The grievances/objections on the eligibility, score awarded, if any were also invited from the candidates at the Email Id: [recruitment2024@hbtu.ac.in](mailto:recruitment2024@hbtu.ac.in) from their registered email Id given in the Application Form, latest by 10.03.2025 (Monday, 07 PM). All grievances received up to 10/03/2025 were again considered by the screening committee. Consequently, the final/freeze eligibility/API scores of the candidates are being displayed with this notification under the recruitment link.

It would be pertinent to mention that all those candidates who are provisionally eligible shall be subject to verification of documents in original (especially related to educational qualifications, caste certificate, experience, research papers etc.) at the time of interview, if called for. Those in employment should submit the “No Objection Certificate” from their present employer at the time of Interview.

**IMPORTANT: All eligible/ provisionally eligible candidates for the post of Medical Officer are hereby informed that,**

- The written test for the post is scheduled on 30/03/2025 at 12:00– 02:00 PM.
- The candidates will be able to download the admit cards for the written test from 24/03/2025 onwards using the login Id and password/Form No.
- The candidates will be required to use the six-digit Roll no. as mentioned in this list on the OMR sheet (On the day of written test).
