NOTIFICATION

The University vide its File No. HBTU/ESTT/01/2024 dated 06.01.2024 had invited online applications in the prescribed format for direct recruitment to faculty positions in various departments of the University. Further, it would be pertinent to mention that all those candidates who are eligible for further stages of recruitment shall be subject to verification of documents in original (especially related to educational qualifications, caste certificate, experience, research papers etc) at the time of interview, if called for.

Please note that all the candidates who have been considered eligible in the lists but have not submitted the **“No Objection Certificate” (NOC)** from their present employer shall have to bring/ submit the same at the time of Interview, if called for.
