### NOTIFICATION

The University vide its File No. HBTU/ESTT./01/2025 dated 15.10.2025 (Advertisement No. Advt. No PC-24) had invited online applications in prescribed format for recruitment of Controller of Examinations on deputation basis for a period of 03 years. The applications of the candidates received up to the last date have been scrutinized by a duly constituted screening/ scrutiny committee and the eligibility decided and scores awarded as per the Recruitment Rules for the post of Controller of Examination and the “Assessment Methodology for calculation of API/ Research Score for the post of Professor” presented in Table C of the “Screening and Selection Criteria for Teaching Positions” uploaded on the website along with the Advertisement. Accordingly, as per the recommendations of the screening/ scrutiny committee, the following list is being uploaded today on the University website [www.hbtu.ac.in](http://www.hbtu.ac.in) (under the “**Recruitment 2025**” tab):

The grievance/ objections should be supported by authentic documentary evidences. Any grievance/ objections received after due date or without any supporting document shall not be entertained. **Candidates are advised to mention clearly their Application id (Form No.), Name, Date of Birth, Department and registered Mobile No. and Post applied for in the email.**

Further, it would be pertinent to mention that all those candidates who are eligible/ provisionally eligible shall be subject to verification of documents in original (especially related to educational qualifications, caste certificate, experience, research papers etc.) at the time of interview, if called for. Those in employment should submit the “No Objection Certificate” (NOC) for deputation from their present employer latest by December 31<sup>st</sup> 2025.

**Note:**

1. Candidates belonging to SC, ST, OBC, EWS category outside U.P. have been considered in UR category, subject to the post advertised under UR category, if any.
2. In case of non-availability of post, in particular category (OBC/EWS/SC/ST), the candidate belonging to these categories have been treated under unreserved category, subject to the posts advertised under UR Category, if any.
3. The University shall not be responsible for any error/omission/relevant information by the applicant knowingly or unknowingly while filling up the application form. In case the applicant gets screened/ shortlisted/ selected/ appointed on the basis of the incorrect/ inadmissible/ forged/ fabricated credentials furnished by him/ her, his/ her candidature shall be liable to be cancelled at any stage of the recruitment/ at any time during the tenure of the service and appropriate legal action under applicable law shall be initiated against the applicant.
