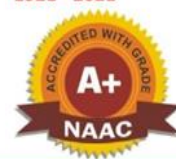

NOTIFICATION

The University vide its File No. 249/Admn/OTTSC/APC Adv-I/2026 dated 05.06.2026 had invited online applications for recruitment of Contractual Positions of Assistant Professor (on Contract) in University Funded & SFS Programmes in various departments of the University. The applications of the candidates received up to the last date have been scrutinized by a duly constituted screening/ scrutiny committee and the eligibility assessed/ scores awarded as per the Recruitment rules and "Assessment Methodology for calculation of API/ Research Score for the post of Assistant Professor (on contract)" presented in Table B of the "Screening and Selection Criteria for Assistant Professor (on contract)" uploaded on the website along with the Advertisement. Accordingly, as per the recommendations of the screening/ scrutiny committee, the following Department wise lists of candidate (with eligibility & API Score) are being uploaded on today i.e July, 4th 2026 on the University website www.hbtu.ac.in (under the "Assistant Professor (on contract) Recruitment 2026-27" tab):

a) Management

These lists mention the candidates who are found eligible/provisionally eligible for the written test scheduled on July 19th 2026 (Sunday) (10:30 am to 12:30 pm). (For further updates in this regard, the candidates are advised to visit the University website regularly)

The candidates are advised to go through these lists. The grievances/objections, if any on the eligibility or API Score, may be submitted at the Email Id: apcrecruitment2026@hbtu.ac.in by the candidates from their registered email Id only given in the Application Form, till July 11th 2026 (Saturday, 05.00 PM). Please Note that many of the candidates have not uploaded the documents and hence have not been awarded API Score. They are advised to send all relevant documents for claim of API Score such as B.Tech Degree & Marksheet, M.Tech Degree & Marksheet, Ph.D Degree, GATE Score Card, Proof of Experience, 1st Page of Research Paper & Proof of award on this email with in stipulated time given as above. The grievance/ objections should be supported by authentic documentary evidences. Any grievance/ objections received after due date or without any supporting document shall not be entertained.

Candidates are advised to mention clearly their Application id (Form No.), Name, Date of Birth, Department and registered Mobile No. and Post applied for in the email.

Further, it would be pertinent to mention that all the candidates who are eligible/ provisionally eligible for Written Test shall be subject to verification of documents in original (especially related to educational qualifications, caste certificate, experience, research papers etc.) at the time of interview, if called for. Those in employment should submit the “No Objection Certificate” (NOC) from their present employer at the time of the Interview.

Note:

1. Candidates belonging to SC, ST, OBC, EWS category outside U.P. have been considered in UR category, subject to the post advertised under UR category, if any.
2. In case of non-availability of post in particular category (OBC/EWS/SC/ST), the candidate belonging to these categories has been considered under unreserved category, subject to the posts advertised under UR Category, if any.
3. The University shall not be responsible for any error or/omission/relevant information by the applicant knowingly or unknowingly while filling up the application form. In case the applicant gets screened/ shortlisted/ selected/ appointed on the basis of the Incorrect/ inadmissible/ forged/ fabricated credentials furnished by him/ her, his/ her candidature shall be liable to be cancelled at any stage of the recruitment/ at any time during the tenure of the service and appropriate legal action under applicable law shall be initiated against the applicant.
