Criteria for sanction of assistance

The eligibility criterion for applying for financial assistance to the regular, registered enrolled student of Economically Weaker Section will be as follows: The EWS students whose gross annual income* from all sources of his/her family**is less than Rs. 8 Lakh (Rs. Eight Latter annual income* from all sources of his/her family**is less than Rs. 8 Lakh (Rs. Eight Lakh only) per anum for the last financial year (ending on 31st March) and his/her family. and his/her family does not own/or possess any of the following assets*** will only be eligible for financial assistance (a income & asset certificate in this respect as enclosed must be produced by EWS students on prescribed format).

- (a) Five acres of agricultural land and above;
- (b) Residential flats of 1000 square ft. and above;
- (c) Residential plot of 100 square yards above in notified municipalities;
- (d) Residential plot of 200 square yards and above in areas other than the notified municipalities;
- 2. The student must be from that category/caste which is not recognized as scheduled caste, schedule tribe and other backward classes as per government list.
- 3. The student should not have any pending back paper/reappear/supplementary exam in any of the subject. In case any student has any pending back paper/reappear/supplementary exam in any of the subject he/she will not be eligible for financial assistance.
- 4. The student should have not been involved in any indisciplinary activity in the University, for which a certificate from DSW/Chief Proctor office is required to be submitted along with application.
- 5. The financial assistance may be given to students maximum upto Ten (10) percent of the sanctioned intake for the particular year in the respective programme.
- Income covered from all sources i.e salary, agriculture, business, profession etc. Income & Asset certificate must be issued after 31st March of the respective year.
- ** The term "family" for this purpose includes the person, who seeks benefit reservation, his/her parents and siblings below the age of 18 years as also his/her spouse and children below the age of 18 years.
- *** The property held by a "family" in different location of different places, cities have been clubbed while applying the land or property holding test to determine EWS status.

Sanction of assistance

- (i) The Ph.D full time/part time registered research students in the HBTU Kanpur will not come in the purview of these rules.
- (ii) In case of emergent situation, the member secretary of the committee shall propose/ sanction financial assistance on an application with the approval of the Vice Chancellor and shall obtain the approval of the committee in its next meeting.
