Instructions for Admission to B.Tech. Program, 2020-21 under Kashmiri Migrants Quota

- 1. Admissions in First year B.Tech. program 2020-21 under Kashmiri Migrants quota will be over and above the sanctioned intake and will be limited to one seat in HBTU, Kanpur as per the latest MHRD instructions.
- 2. The candidates, opting for admission under this scheme, need not appear in JEE(Main)-2020
- 3. Candidates seeking admission under this quota must have clearly passed Intermediate examination of U.P. Board or 10+2 level examination or its equivalent from any recognized Board / University without grace and with a minimum 50% marks (45% marks for SC / ST Category candidates) in aggregate in two compulsory subjects (Physics and Mathematics) along with one of the Chemistry / Biotechnology / Biology / Technical Vocational subject. In addition, candidate should have studied a minimum of five subjects (including the above three) in his / her qualifying examination.
- 4. Eligible candidates may send their applications on the prescribed format for admission against Kashmiri Migrants quota to "Admission Co-ordinator, Office of Dean Academic Affairs, Harcourt Butler Technical University, Kanpur-208002 (U.P.)" along with a Demand Draft (Non-refundable) of Rs. 2500=00 in favour of "Finance Controller, Harcourt Butler Technical University, Kanpur" payable at Kanpur.
- 5. The last date for receipt of application form in the office of the Registrar of the University is **October 29**, **2020** at 5:00 pm.
- 6. Applications without declaration of the result of qualifying examination or incomplete in any respect will not be considered.
- 7. The shortlisted candidates for counseling will be displayed on the University's website http://www.hbtu.ac.in on November 2, 2020.
- 8. The date of counseling for the shortlisted candidates is **November 10, 2020** at HBTU, Kanpur. The candidates are required to report to Academic Section of HBTU Kanpur at 11:00 AM.
- 9. The candidates are advised to see the notice for any change in the display of shortlisted candidates & counseling dates on University website http://www.hbtu.ac.in. No counseling letter will be sent to the candidates separately.
- 10. At the time of counseling, the candidates have to submit three passport size colour photographs and their original documents along with one set of photocopies of the following:
 - (a) Marksheet of 10+2 or equivalent examination
 - (b) High School 10th Standard certificate
 - (c) Proof of claiming quota, i.e. Kashmiri Migrants
 - (d) Bank Draft of Rs. 12000=00 in favour of "Finance Controller, Harcourt Butler Technical University, Kanpur" payable at Kanpur. If a candidate is admitted to the B.Tech. program, the fee would be adjusted with the Academic fee, else it would be refunded.
- 11. The latest Government Orders shall be applicable for admission under Kashmiri Migrants Quota.
- 12. Candidates are advised to keep visiting the website http://www.hbtu.ac.in frequently for updates. The notices placed on the website shall be treated as served to the candidates.
