## **Annexure-A**

**The minimum conditions to be covered in the policy are as follows:**

1. Cashless facility will be provided by Insurance Company & its TPA.
2. Claim having less than 24 hrs hospitalisation relating to cases of food poisoning, minor injury, dehydration & like nature diseases will also be paid subject to a maximum amount of Rs.5,000/- per students.
3. No capping in room rent (Hospital rooms as well as ICU charges) and on nursing charges.
4. The approval for cashless for Hospitalisation will be managed by TPA within 2 hrs. of intimation from Hospital on all days including Saturday, Sunday & Holidays.
5. The final settlement of claims will also be the done on the date of discharge by TPA. within the sum insured, there will be no deduction admissible for any kind of expenses in Hospital bills.
6. Separate TPA Cards will be issued for each student subject to submission of names, Date of Birth, Branch on standard format of insurance Company to be provided by TPA within 7 days of receipt of premium amount. The identity card of student may also be used as identity proof at the time of Hospitalisation.
7. Few Hospitals in the close vicinity of HBTU could be nominated by TPA to avoid delay in treatment at the Hospital & Name of those Hospitals with contact person and mobile no. will be provided by Insurance Company within 7 days of receipt of premium amount.
8. If student is treated in non networking hospitals, in that case the reimbursement of claim will also be made within 30 days from the date of submission of all original documents subject to the condition that the claim should be intimated to TPA within 7 days from the date of admission in Hospital.
9. The cheque against Reimbursement of claim will be issued in the name of student concerned subject to the confirmation of identity on the part of HBTU.
10. All pre existing diseases will be covered from first day.
11. The details of insurance benefits extended to beneficiary and the details of claims disallowed are to be submitted by insurer in every three months.
12. Ambulance reimbursement is to be covered in case of emergency treatment.
13. Vice-Chancellor of HBTU will be fully authorized to reject any quotation without assigning any reason.

Detailed list of all students with names, date of birth, branch etc will be forwarded to you with premium amount for issuance of policy and TPA cards.
