NOTICE

This is to inform that HBTU-TBI Foundation has launched a Zero Rental Scheme for incubation of new startups. The important features of this scheme are given below:

1. HBTU-TBIF will not charge rent under zero rental scheme for a maximum period of 01 year (2024-25).
2. All startup have to apply on an Incubation Form (**Annexure -A**). All proposals will be reviewed by a committee.
3. Initially, registration under Zero Rental Scheme will be done for 06 months on the recommendation of committee. It will be extended on the condition of satisfactory progress after every 03 months till maximum tenure of zero rental Incubation - 01 year.
4. Startups should agree to be incubated with existing facilities / infrastructure available at HBTU-TBIF. They have to submit a declaration in this regard (**Declaration Annexure-B**).
5. It was decided that equity should not be claimed until unless any fund is given to startups from HBTU-TBIF.
6. Zero Rental Incubation can be terminated with 07 days' notice in any unavoidable situation or if anything objectionable is done by incubatee.

Startups interested to be incubated under the above scheme have to apply on prescribed formats latest by July 16, 2024 (Email - dih@hbtu.ac.in)
