- Harcourt Butler Technological Institute, Kanpur was transferred to the list of colleges under section 2f and 12B of the UGC Act 1956 (<https://www.ugc.ac.in/oldpdf/colleges/List-of-colleges-as-on-30-04-2022.pdf>) (Annex 2)
- University had sent a letter to UGC vide Letter No. 46/RO/Ext/2016 dated 28/10/2016 about intimation of conversion of "Harcourt Butler Technological Institute (H.B.T.I.), Kanpur" to a University named "Harcourt Butler Technical University (H.B.T.U.), Kanpur" and requesting to include the name of H.B.T.U., Kanpur in the UGC list of State Universities. (Annex 3)
- UGC had sent a letter to H.B.T.U., Kanpur vide Letter No. F.9-19/2016 (CPP-1/PU) dated 07/12/2016 requesting to submit attested copy of the Act of HBTU, Kanpur alongwith attested copy of the Notification issued by the Government of Uttar Pradesh (Annex 4)
- After submission of the above information to UGC, New Delhi, a letter with Letter No. F.9-19/2016 (CPP-1/PU) dated 22/02/2017 was received by HBTU, Kanpur wherein it is mentioned that University H.B.T.U., Kanpur-208002, UP, has been established by an Act No. 11 of 2016 of State Legislature of Uttar Pradesh as a State University vide Notification No. 586(2)/LXXIX-V-1-16-1(ka)-10-2016 dated 07/04/2016 and is empowered to award degrees as specified by the UGC under section 22 of the UGC Act 1956 through its own departments, its constituent colleges and/or through its affiliated colleges in regular mode with approval of concerned statutory bodies/councils, wherever required (Annex 5)
- Further, University has sent a fresh request with reference no. 1787/Admn./GA/UGC/2022 dated 20/11/2022 to UGC separately to issue the Notification regarding reiteration of the status of 2f with effect from its date of establishment i.e. 01/09/2016 (Annex 6)
- University is already appearing in the UGC list of State Universities (Annex 7)

In pursuance of the provisions of clause (3) of Article 348 of the Constitution of India, the Governor is pleased to order the publication of the following English translation of the Uttar Pradesh Harcourt Butler Pravidhik Vishwavidyalay Adhiniyam, 2016 (Uttar Pradesh Adhiniyam Sankhya 11 of 2016) as passed by the Uttar Pradesh Legislature and assented to by the Governor on April 6, 2016.

THE UTTAR PRADESH HARCOURT BUTLER TECHNICAL UNIVERSITY ACT, 2016

(U.P. Act no. 11 of 2016)

[As passed by the Uttar Pradesh Legislature]

AN

ACT

to provide for reconstitution of the Harcourt Butler Technological Institute, Kanpur as the Harcourt Butler Technical University, Kanpur with a view for making it a leading Residential University to become a Centre of Excellence with focus on Research & Development and Incubation in the fields of engineering, technology, basic & applied sciences, humanities, social science & management, architecture and other professional courses, to promote studies, research and innovation in emerging areas of higher education, to further skill development through continuing education programme and knowledge incubation, also to achieve excellence in higher technical education and other matters connected therewith or incidental thereto.

WHEREAS the Harcourt Butler Technological Institute run under Harcourt Butler Technological Institute (Kanpur) Society, is an institution of Government of Uttar Pradesh affiliated to Dr. A.P.J. Abdul Kalam Technical University, Uttar Pradesh, Lucknow;

AND, WHEREAS, it is expedient to confer on the said institution, the status of a University to enable it to function more efficiently as the teaching and research center to meet the requirement of higher education and research in the field of engineering and technology, applied sciences & management sciences, foster industry relevant research & innovation and to avail better scopes and opportunities to serve the society and the nation.

IT IS HEREBY enacted in the Sixty-seventh Year of the Republic of India as follows:-

CHAPTER -I

PRELIMINARY

Short title and commencement

1. (1) This Act shall be called the Uttar Pradesh Harcourt Butler Technical University Act, 2016.

(2) It shall come into force on such date as the State Government may, by notification, appoint.

Definitions

2. In this Act, unless the context otherwise requires,—

(1) "Academic Council" and "Executive Council" means respectively the Academic Council and the Executive Council of the University;

(2) "Adjunct Professor", "Adjunct Associate Professor" or "Adjunct Assistant Professor" mean a person from academia, industry, trade, agriculture, commerce or any other allied field who is so designated during the period of collaboration or association with the University;

(3) "Authority" means an authority of the University;

(4) "Council" means the All India Council for Technical Education, established under the All India Council for Technical Education Act, 1987 (Act no. 52 of 1987);

With reference to your letter No.180/क०स०क०/इन्ट/2017 dated - 21.01.2017 on the subject cited above, I am directed to say that **Harcourt Butler Technical University, Kanpur - 208 002, Uttar Pradesh** has been established by an **Act No.11 of 2016** of State Legislature of Uttar Pradesh as a State University vide **Notification No.586(2)/LXXIX-V-1-16-1(ka)-10-2016** dated - **07.04.2016** and is empowered to award degrees as specified by the UGC under section 22 of the UGC Act 1956 through its own departments, its constituent colleges and/or through its affiliated colleges in regular mode with the approval of concerned statutory bodies/councils, wherever required.

The University is not allowed to start any off-campus centre beyond the territorial jurisdiction of the State as per Hon'ble Supreme Court Judgment in Prof. YashPal vs State of Chhattisgarh case.

The University may note and adhere to the following: -

To ensure that no off campus centre(s)/study centre and the centres operating through franchises is opened by the University outside the territorial jurisdiction of the State in view of the judgment of Hon'ble Supreme Court of India in case of Prof. Yashpal vs. Government of Chhattisgarh.

If the university has already started any off-campus/study centre and the centre operating through franchises outside the State, it must be closed immediately.

No distance education programmes shall be started without the prior approval of UGC.

M.Phil/ Ph.D programmes can be conducted as per the provisions of UGC (Minimum Standards and Procedure for Awards of M.Phil/ Ph.D. Degree) Regulations, 2009.

The University is required to follow all the UGC Regulations notified and available on UGC website www.ugc.ac.in.


