Terms & Conditions

1. General Terms and Conditions:

- 1.1 The Scope of the work includes Supply, Installation, Testing & Commissioning (STC), pro-active monitoring and maintenance during the contract period of Wi-Fi system at mentioned locations in the BSNL proposals (annexure- (Page No.139 to 141)
- 1.2 BSNL will take care of end-to-end deployment, O&M activities and ensure that each location can be Go-Live within 60 Days from the date of issue of the work order.
- 1.3 All regulatory & security parameters will be met. Customer Support 24x7 will be made available by BSNL Kanpur.
- 1.4 Ticketing tool as per mutually agreed SL.A.
- 1.5 Network uses reports will be provided to the HBTU Kanpur for the verification.
- 1.6 AAA services for authentication of the internet session as per prevailing guidelines Login Page and other interfaces can be customized as per the requirement of HBTU Kanpur.
- 1.7 Escalation Matrix and Contact details shall be shared by BSNL Kanpur to HBTU, Kanpur.
- 1.8 No capping on Data per user from BSNL side: U/L volume of Data usage. However capping may be done by BSNL on request of HBTU as per the HBTU policy.
- 1.9 A list of all 14 Hostels and 36 Academic buildings covered is as mentioned in the BSNL. Proposal (annexure-1).
- 1.10 Work Permission to BSNL for Cable laying at site/necessary Space etc. will be provided by HBTU, Kanpur.
- 2. Minimum Contract Period: As per issued Work Order.
- 3. Payment Terms: As per terms and conditions of the University.
- 4. Penalty Clause: BSNL should maintain 98% network uptime per Access Point (AP) along with Internet Service Provided by ISPs. BSNL should provide reports of the uptime of Access Point and bandwidth utilization along with the invoices raised payment and for calculating penalties if any as per SLA parameters shared below:
 - 4.1 No penalty: if the uptime in a quarter is 98% or more, no penalty will be levied on the quarterly charges.

- 4.2 Level I penalty: In the event of the uptime of the service being below 98%, for every 1.0% drop in the uptime percentage, a penalty of 0.25% of the quarterly charges shall be levied for the service. The quarterly penalty shall not be more than 10% of proportionate quarterly charge. (For example. In a quarter (of 90 days) if Total cumulative downtime is 1.8 days (43.2 hr.) then there will be no penalty. For downtime more than 1.8 days, for each and every 1%downtime increase (1.e. 0.9 days 22 hrs) there will be a penalty of 0.25% of the quarterly charges.
- Memorandum of Understanding (MoU) will be signed later on between HBTU and BSNL to clearly state their objectives and what they expect from One another.
