Anti-ragging Squads 2021-22

In order to have effective control over the incidence of ragging as per the **guidelines of Hon'ble Supreme Court of India**, UGC Regulations on curbing the menace of Ragging in Higher Educational Institutions 2009 dated 04/07/2009, **AICTE notification on Prevention and Prohibition of Ragging in Technical Institutions**, Universities including Deemed to be Universities imparting technical education, dated 01/07/2009 and to maintain overall discipline amongst the students, the following **Anti-ragging Squads** are proposed.

East Campus and nearby areas have been divided into three Zones. West Campus is the fourth zone. Each zone will have an **Anti-ragging Squad Leader** to supervise and coordinate the working of the squads. The members of the various squads are requested to remain present, be vigilant and take round in their respective areas for effective checking of the incidence of ragging. The **Anti-ragging Squad Leader** are requested to divide the members in units as per availability to work in shifts from 9:00 AM to 7:00 PM and send a copy to the Chief Proctor and DSW for information. In case of any incidence of ragging in their zone, the **Anti-ragging Squad Leaders** are requested to communicate it to the Vice Chancellor/Registrar immediately. Dean Students' Welfare and Chief Proctor will be available to extend all necessary help in this regard.

The Anti-ragging Squads will start functioning from morning of November, 2021 and shall continue to work till further orders. All the **Anti-ragging Squad Leaders** are advised to have a meeting of their respective committee members and intimate regarding the placement of the members shift wise to the Registrar, Dean Students' Welfare & Chief Proctor. In absence of **Anti-ragging Squad Leader**, 1st Member of the team will look after the responsibilities of **Anti-ragging Squad Leader**.

- 1- It shall be the duty of the Anti-ragging Squads to make surprise raids on hostels with wardens, and other places in and around University vulnerable to incidents and having the potential for ragging.
- 2- It shall also be the duty of the Anti-Ragging Squads to conduct an on-the-spot enquiry into any incidents of ragging referred to it by the Head of the institution or any member of the faculty or any member of the staff or any student or any parent or guardian or any employee of a service provider or by any other person, as the case may be; and the enquiry report along with recommendations shall be submitted to the Chief Proctor for action. Anti-Ragging Squad shall conduct such enquiry observing a fair and transparent procedure and the principles of natural justice and after giving adequate opportunity to the student or students accused of ragging and other witnesses to place before it the facts, documents and views concerning the incidents of ragging, and considerations such other relevant information as may be required.
- 3- In case of any ragging incidence, the Anti-Ragging Squad leader will also submit a report to Chief Proctor separately who will make arrangements for forwarding of such reports to the Head of Institution and shall keep a copy with himself/ herself.
- 4- No leave application shall normally be entertained during the duty period. In case of exceptional requirement of leave, the same should be submitted stating reasons to Chief Proctor with specific recommendation of respective Anti-Ragging Squad leaders and it will be sanctioned by the Head of Institution.
- 5- Dean/Associate Dean, Students' Welfare shall ensure discipline inside all the Hostels with the help of concerned warden(s).
- 6- At the time of locking and opening of Hostels having newly admitted students, Warden of respective Hostels shall make arrangements for attendance of inmates. No student will leave hostel without prior

permission of Warden. If any student is found absent without prior permission of Warden of concerned Hostel, the same has to be reported to the Dean/Associate Dean Students' Welfare.

- 7- It shall be the duty of respective Anti-Ragging Squad to ESCORT first year students with the help of security guards from Hostels (having newly admitted students) to classes and going back from classes to Hostels.
- 8- The Hostels of newly admitted students (both boys and girls) will remain closed from 8.00 pm to 06.00 am.
- 9- Dean Students' Welfare, Associate Dean Students' Welfare, Dean Academic Affairs, Chief Proctor, Dy. Chief Proctor will take frequent rounds of the hostels and other sensitive places within and around University especially during night hours.
- 10- Registrar and other officers will also take necessary steps to avoid any ragging incident in and around the University campus.
- 11- University Ambulance with driver will be available as and when required.
- 12- University Medical Officer should be available in person on phone to attend any medical emergency. He/She has to make sure that life saving drugs and other routine medicines are available in the dispensary.
- 13- Neither honorarium nor any other type of payment will be made for these duties.

It is requested that this duty must be given top priority to make this session also free from any incidence of RAGGING.

5. Outsider i.e. those not residing in the hostel cannot normally become a member of the mess. However, the Warden is empowered to allow outsiders to take meals in the mess for a brief period only. Outsider means non-hosteller University students or ex-hostellers or members of the staff.

3.4 Student Discipline

3.4.1 General Conduct

Each student shall conduct himself, both within and outside the University, in a manner befitting the traditions of this University. Ragging in any form, inside or outside the University is strictly prohibited. The students are advised to go through the standing orders given below under section In case of any act of ragging, indiscipline, vandalism and loss to the University property, necessary disciplinary action will be taken by the Chief Proctor/Proctorial Board of the University. The Wardens, Dean and Associate Dean, Students' Welfare are responsible for welfare issues of all students of the University. The students can also approach the concerned Head of Departments/Wardens/Dean and Associate Dean, Students' Welfare, for solution to their problems and guidance.

3.4.2 Standing Orders for Students

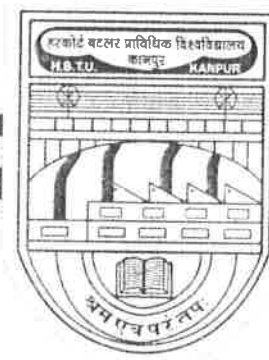
Students of the University should go through these Standing Orders carefully and also make themselves familiar with the rules, regulations and other instructions. Apart from the standing orders mentioned here they have to abide by the notices/orders issued from time to time, pertaining to their academic, curriculum, and other activities. Any amendments and additions to these standing orders will be notified through notices displayed on the notice boards and circulated in the usual manner. In case of any difficulty or requiring assistance, they should contact the authorities concerned as indicated in these orders. The plea of ignorance will not be entertained for any breach of orders in force from time to time. Apart from academic work they are expected to take full part in other student's activities also. Students having attendance less than 75% or as decided by the University will not be eligible for appearing in class test and End semester Examination. They may be debarred from placements, interviews for which they themselves shall be responsible.

Disciplinary matters of students within and outside the University are dealt by the Proctorial Board headed by the Chief Proctor. The Proctorial Board of the University will investigate all the acts of indiscipline reported and shall recommend suitable punishment for approval to the Vice-Chancellor. Violation of the code of conduct by a student or a group of students can be referred to the Chief Proctor.

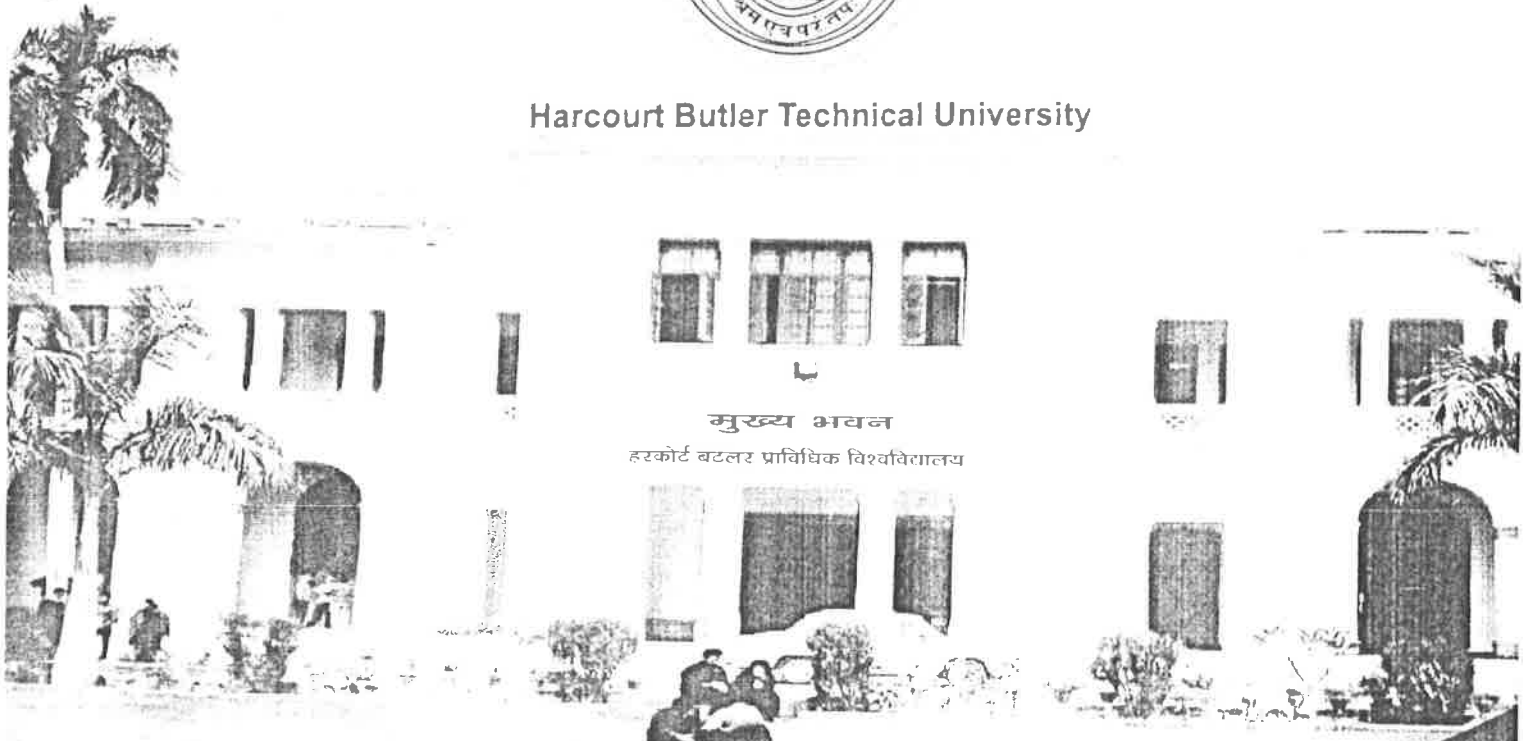

Code of Discipline

No student is expected to indulge in any activity which brings down the prestige of the University. Students shall show due respect and courtesy to the teachers and employees of the University. They should also pay due courtesy to the visitors and residents of the Campus.

Lack of courtesy and unbecoming conduct (both within and outside the University) willful damage of University property, breach of rules and regulations of the University and similar other undesirable activities shall constitute violation of the code of conduct.

Violation of the code of conduct shall invite disciplinary action and may lead to punishments, such as reprimand, fine, debarring from examination / placement / cancellation of registration and even dismissal from the University.

Warden of the concerned hostel shall have power to reprimand or impose fine against any inmate of the hostel who violates the code of conduct. Warden can also take other suitable actions in consultation with the Dean of Students Welfare or Chief Proctor as desired.

Students will not be allowed to pursue at any other formal course/examination during their stay in the University. Except with the written permission of the Vice Chancellor.

Use of liquor, drugs or any other intoxicants in the University premises including hostel is strictly prohibited.

Students are warned against any fraud in money related matters. All such cases which lead to discredit to the University will invite disciplinary action. University shall not be responsible for any debts to the students and its consequences.

Students must pay all their University, Mess and other dues before the stipulated dates. Failure to deposit the dues in time may result in fine or any other penalty as deem fit.

Students must carefully handle the laboratory equipments, instruments, machines, and plants during their course of study. Pasting unauthorized notices is strictly prohibited.

Get-together outside the University campus is strictly prohibited without prior permission of the concerned person in University administration.

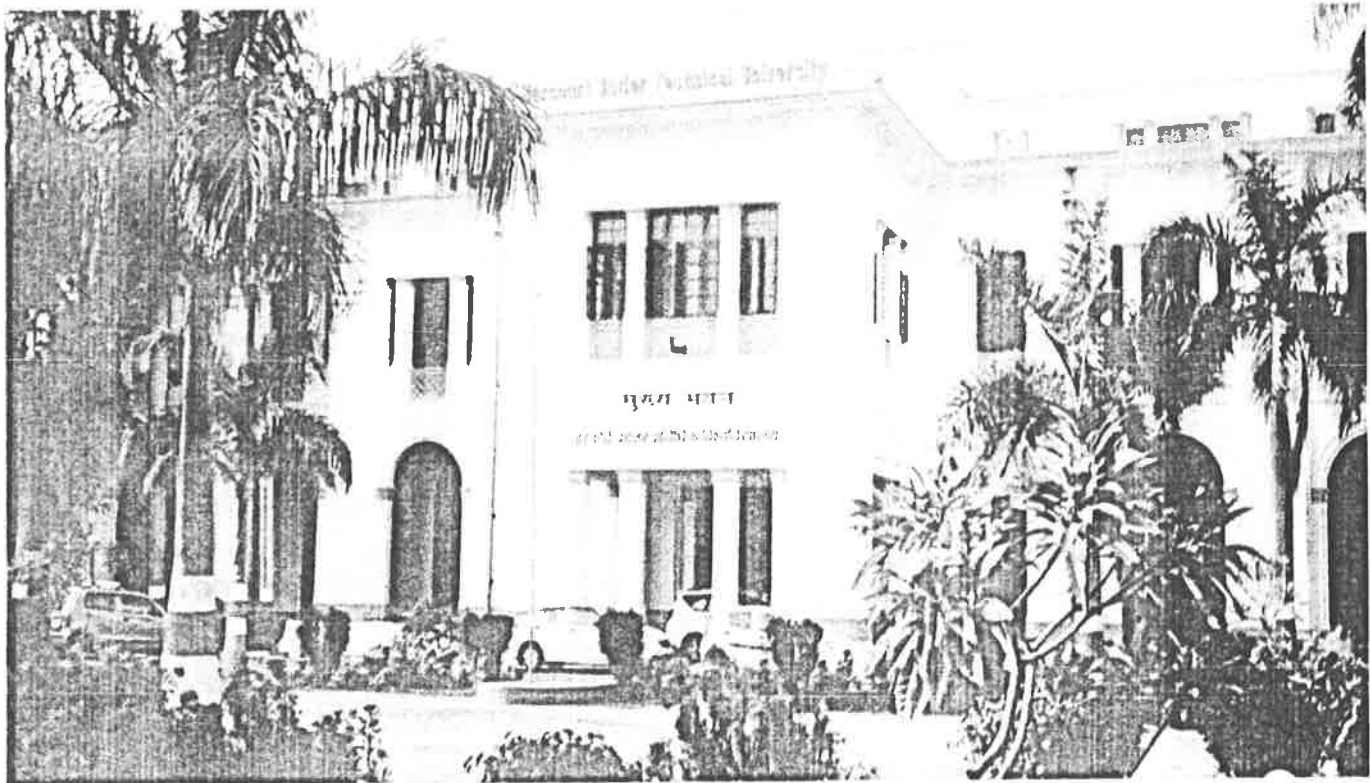

Outsiders i.e. those not residing in the hostel cannot normally become a member of the mess. However, the Warden is empowered to allow outsiders to take meals in the mess for a brief period only. Outsider means non-hosteller university students or ex-hostellers or members of the staff.

Efforts are being made to run the mess facility with the help of reputed firms engaged in providing such services.

4.4 Student Discipline

4.4.1 General Conduct

Each student shall conduct himself, both within and outside the university in a manner befitting the traditions of this university. Ragging in any form, inside or outside the university is strictly prohibited. The students are advised to go through the standing orders given below under section 14.2. In case of any act of ragging, indiscipline, vandalism or loss to the university property, necessary disciplinary action is taken by the Chief Proctor / Proctorial Board of the University. The Wardens, Dean and Associate Dean, Student Welfare are responsible for welfare issues of all the students of the University. The students can also approach the concerned Head of Departments / Wardens / Dean and Associate Dean, Students Welfare for solution to their problems and guidance.

4.4.2 Standing Orders for Students

Students of the university should go through these Standing Orders carefully and also make themselves familiar with the rules, regulations and other instructions. Apart from the standing orders mentioned here they have to abide by the notices / issued from time to time, pertaining to their academic, curriculum, and other activities. Any amendments and additions to these standing orders will be notified through notices displayed on the notice boards and circulated in the usual manner. In case of any difficulty or requiring assistance, they should contact the authorities concerned as indicated in these orders. The plea of ignorance will not be entertained for any breach of orders in force from time to time. Apart from academic work they are expected to take full part in other activities also. Students having attendance less than 75% or as decided by University will not be eligible for appearing in class test and End Semester Examination. They may be debarred from placements interviews for which they themselves shall be responsible.

Disciplinary matters of students within and outside the University are dealt by the Proctorial Board headed by the Chief Proctor. The Proctorial Board of the University will investigate all the acts of indiscipline reported and shall recommend suitable punishment for approval to the Vice-Chancellor. Violation of the code of conduct by a student or a group of students can be referred to the Chief Proctor.



Anti-ragging Squads 2020-21

In order to have effective control over the incidence of ragging as per the guidelines of Hon'ble Supreme Court of India, UGC Regulations on curbing the menace of Ragging in Higher Educational Institutions 2009 dated 04/07/2009, AICTE notification on Prevention and Prohibition of Ragging in Technical Institutions, Universities including Deemed to be Universities imparting technical education, dated 01/07/2009 and to maintain overall discipline amongst the students, the following **Anti-ragging Squads** are proposed.

East Campus and nearby areas have been divided into three Zones. West Campus is the fourth zone. Each zone will have an **Anti-ragging Squad Leader** to supervise and coordinate the working of the squads. The members of the various squads are requested to remain present, be vigilant and take round in their respective areas for effective checking of the incidence of ragging. The **Anti-ragging Squad Leader** are requested to divide the members in units as per availability to work in shifts from 9:00 AM to 7:00 PM and send a copy to the Chief Proctor and DSW for information. In case of any incidence of ragging in their zone, the **Anti-ragging Squad Leaders** are requested to communicate it to the Vice Chancellor/Registrar immediately. Dean Students' Welfare and Chief Proctor will be available to extend all necessary help in this regard.

The Anti-ragging Squads will start functioning from morning of February 11th, 2021 and shall continue to work till further orders. All the **Anti-ragging Squad Leaders** are advised to have a meeting of their respective committee members and intimate regarding the placement of the members shift wise to the Registrar, Dean Students' Welfare & Chief Proctor. In absence of **Anti-ragging Squad Leader**, 1st Member of the team will look after the responsibilities of **Anti-ragging Squad Leader**.

- 1- It shall be the duty of the Anti-ragging Squads to make surprise raids on hostels with wardens, and other places in and around University vulnerable to incidents and having the potential for ragging.
- 2- It shall also be the duty of the Anti-Ragging Squads to conduct an on-the-spot enquiry into any incidents of ragging referred to it by the Head of the institution or any member of the faculty or any member of the staff or any student or any parent or guardian or any employee of a service provider or by any other person, as the case may be; and the enquiry report along with recommendations shall be submitted to the Chief Proctor for action. Anti-Ragging Squad shall conduct such enquiry observing a fair and transparent procedure and the principles of natural justice and after giving adequate opportunity to the student or students accused of ragging and other witnesses to place before it the facts, documents and views concerning the incidents of ragging, and considerations such other relevant information as may be required.
- 3- In case of any ragging incidence, the Anti-Ragging Squad leader will also submit a report to Chief Proctor separately who will make arrangements for forwarding of such reports to the Head of Institution and shall keep a copy with himself/ herself.
- 4- No leave application shall normally be entertained during the duty period. In case of exceptional requirement of leave, the same should be submitted stating reasons to Chief Proctor with specific recommendation of respective Anti-Ragging Squad leaders and it will be sanctioned by the Head of Institution.
- 5- Dean/Associate Dean, Students' Welfare shall ensure discipline inside all the Hostels with the help of concerned warden(s).
- 6- At the time of locking and opening of Hostels having newly admitted students, Warden of respective Hostels shall make arrangements for attendance of inmates. No student will leave hostel without prior permission of Warden. If any student is found absent without prior permission of

Warden of concerned Hostel, the same has to be reported to the Dean/Associate Dean Students' Welfare.

- 7- It shall be the duty of respective Anti-Ragging Squad to ESCORT first year students with the help of security guards from Hostels (having newly admitted students) to classes and going back from classes to Hostels.
- 8- The Hostels of newly admitted students (both boys and girls) will remain closed from 8.00 pm to 06.00 am.
- 9- Dean Students' Welfare, Associate Dean Students' Welfare, Dean Academic Affairs, Chief Proctor, Dy. Chief Proctor will take frequent rounds of the hostels and other sensitive places within and around University especially during night hours.
- 10- Registrar and other officers will also take necessary steps to avoid any ragging incident in and around the University campus.
- 11- University Ambulance with driver will be available as and when required.
- 12- University Medical Officer should be available in person on phone to attend any medical emergency. He/She has to make sure that life saving drugs and other routine medicines are available in the dispensary.
- 13- Neither honorarium nor any other type of payment will be made for these duties.

It is requested that this duty must be given top priority to make this session also free from any incidence of RAGGING.
