HEI Response: (2) Certificates of students enrolled in such courses and also attendance sheets of courses year wise and program wise duly signed by competent authority

HEI wants to clarify that different value added courses are organized through its various bodies like University Student Activities Council (USAC) under Dean Student Welfare, Placement Cell under Dean Planning and Resource Generation (Dean, PR&G), various departments of the University. Few of these courses are mandatory for first year students like motivational, creative and life skills, physical education which are imparted through Induction Program for new entrants. Apart from that, few courses are mandatory for third and final year students for their professional and personality development for future avenues. Along with that, few courses are run as Audit Courses (which does not contain any credit and hence are not counted in the computation of CGPA).

Regarding certificates given to students enrolled in these courses, HEI wants to clarify that, **it does not issue certificates to the students** for these value added courses. However, these courses are organized after proper financial/administrative approval from the University. Attendance and record keeping of these courses is maintained.
